PROCEDURES**

1 I, LANA LUCCHESI, declare and state as follows:

2 1. I am a Director with KCC Class Action Services, LLC (“KCC”), located at 3301
3 Kerner Boulevard, San Rafael CA 94901. Pursuant to the Preliminary Approval Order of Class
4 Action Settlement (the “Preliminary Approval Order”) dated July 16, 2019, the Court appointed
5 KCC as the Claims Administrator in connection with the proposed Settlement of the above-
6 captioned Action.¹ I have personal knowledge of the matters stated herein and, if called upon,
7 could and would testify thereto.

8 2. The purpose of this declaration is to provide updated statistics based on my last
9 declaration executed on January 23, 2020

10 **SETTLEMENT WEBSITE**

11 3. On or about October 30, 2019, KCC established a website
12 [www.SentraVersaCVTSettlement.com] dedicated to this proposed settlement to provide
13 information to the Class Members and to answer frequently asked questions. The website URL
14 was set forth in the Postcard Notice, Long-Form Notice, and Claim Form. Visitors of the website
15 can download copies of the Long-Form Notice, Claim Form, and other case-related documents.
16 Visitors can also submit claims online and upload supporting documentation. As of February 21,
17 2020, the website has received 173,516 visits.

18 **TELEPHONE HOTLINE**

19 4. KCC established and continues to maintain a toll-free telephone number (1- 855-
20 222-6841) for potential Class Members to call and obtain information about the Settlement,
21 and/or request a Long Form Notice and Claim Form. The telephone hotline became operational
22 on October 30, 2019, and is accessible 24 hours a day, 7 days a week. As of February 21, 2020,
23 KCC has received a total of 60,710 calls to the telephone hotline.
